- Original Social Security card or Individual Taxpayer Identification Number (ITIN) for everyone listed on the tax return.
- Copy of last year's tax return
- All W-2 wage statements for 2023.
- SSA-1099, 1099-R and 1099-G
- Cash income amount and work expenses.
- 1095 health coverage form
- Direct deposit information
