## G7- B7 Joint Workshop on the Circular Economy and Resource Efficiency Principles

November 2, 2023

The significance of resource efficiency and circular economy approaches to achieve sustainable consumption and production, as well as the resource-climate-biodiversity-pollution nexus have been recognized and mainstreamed multilaterally including through UNEA/UNGA resolutions, G7, G20 and other fora. Businesses and private sector play an essential role in addressing value chain sustainability thereby improving resource efficiency and making our economies more circular.

In this context, building on the preceding G7 processes<sup>1</sup>, the G7 Ministers of Climate, Energy and the Environment met on 15-16 April 2023 in Sapporo, and, as an annex to the resulting communique, adopted the Circular Economy and Resource Efficiency Principles (CEREP)<sup>2</sup>, aiming to encourage companies to establish initiatives and step up actions on a circular economy, to promote engagement with the public and the financial sector and to promote their voluntary circular economy and resource efficiency <sup>3</sup>. G7 Leaders at Hiroshima Summit further endorsed CEREP<sup>4</sup>.

CEREP contains 6 core principles covering dimensions including leadership commitment/governance, integration of circular economy and resource efficiency approaches with climate and nature and pollution strategies, transition to more circular and resource efficient business models, enhanced monitoring and reporting and multi-stakeholder partnerships and engagement.

Prior to the G7 Leaders' Summit, B7 submitted the G7 the "B7 Tokyo Summit Joint Recommendations<sup>5</sup>" including a request for a dialogue with the G7, sharing of best practices, implementation of policies addressing product design and the use of circular materials while investing in the enabling infrastructures. Engagement and collaboration with the B7 for the utilization of the CEREP and fostering public-private partnership were also included in the G7 Ministerial communique at Sapporo.

In light of the above, this workshop is co-organized under the initiative of Japanese G7 and B7 Presidencies with the aim of encouraging business community to fully utilize the principles in integrating circular economy and resource efficiency approaches to their corporate governance and business models. To this end, the event will provide opportunity for the G7 to communicate CEREP as well as their policies for promoting circular economy, while encouraging the B7 to share best practices, put forward policy needs (establishing enabling business environment) from the business community and engage in dialogue with the G7.
